Excerpt from the Terms and Conditions of Membership of the CKM Association for Students, Youth and Teachers (hereinafter referred to as the "CKM SYTS") for natural persons with regard to becoming a member through cooperation with a college/university.

The full wording of the Terms and Conditions of Membership of CKM SYTS for all members is included in the Association's statutes, which are published at http://ckmsyts.sk/dokumenty/stanovy_zdruzenia_CKM_SYTS.pdf.

MEMBERSHIP OF THE ASSOCIATION

1.1/ CKM SYTS is a voluntary association and no member thereof shall be restricted on his/her rights. This principle is considered to be the core principle of CKM SYTS's activity.

ESTABLISHMENT OF THE MEMBERSHIP

2.1/ Members of the Association may be as follows:

- Natural persons
- Natural persons – Students of full-time study
- Natural persons – Teachers
- Legal entities

2.1.1/ A natural person shall become a member of the Association upon filling in the membership application - the Registration sheet and payment of the first membership fee for natural persons, proving his/her membership using member card.

2.1.2/ In case of failure to pay the membership fee for the relevant period specified by the Board of Directors according to paragraph 3.3. of present Statutes by a member of the Association, such member shall remain a member of the Association but his/her membership rights shall be limited and s/he shall have only the rights similar to the Associate Member and s/he shall temporarily lose the right to prove his/her membership using his/her membership card. Upon due payment of the membership fee, the member's membership rights shall be restored to the original standard. The extent of the rights of a member of CKM SYTS shall therefore be dependent on the payment of membership fee for the period in question.

MEMBERSHIP CARDS

3.1/ CKM SYTS issues and distributes following membership cards:

- a) ISIC card (International Student Identity Card), for students of full-time study at schools accredited by the Ministry of Education of the Slovak Republic,
- b) ITIC card (International Teacher Identity Card), for teachers of schools accredited by the Ministry of Education of the Slovak Republic,
- c) EYCA/EURO<26 youth card for natural persons aged under 30 inclusive.

3.2/ The name of the member of the Association - the holder of the card and the period of validity of the card, shall be listed thereon among other items.

RIGHTS AND OBLIGATIONS OF MEMBERS

4.1/ A member of the Association referred to in paragraph 2.1 shall be entitled to use all the benefits and discounts resulting from membership of the Association notified to him/her or listed in the Information Guide/Association website after having submitted his/her membership card, in particular s/he shall have the right to:

- a) enjoy discounts and benefits in transport, accommodation, travel and culture,
- b) participate in the organized meetings and other activities of CKM SYTS,
- c) regularly receive information regarding the extent and possibilities of discounts and benefits resulting from membership of CKM SYTS at home and abroad.

4.2/ A member of the Association referred to in paragraph 2.1 is obliged to submit a valid membership card when enjoying particular benefits and discounts, and upon request of the provider of a discount, s/he is also obliged to submit another personal identification card.

4.3/ Pursuant to the Statutes a member of the Association shall receive information about the possibilities of enjoying benefits resulting from association membership (use of membership cards) to an e-mail or postal address specified by such member. Upon establishment of a membership, a member of the Association, in accordance with the previous provisions, agrees to the regular sending of the offers to enjoy benefits from membership of the Association. A member of the Association is aware that the offers under the previous sentence may have the character of marketing and possibly advertising, and s/he does not reject receiving such offers. A member of the Association shall have the right to object at any time or, as the case may be, to withdraw the consent under this paragraph and the right to refuse sending such offers as well. For the purposes of this provision, a natural person shall also be considered to be a member of the Association at the time after signing the application until the payment of the first member fee.

TERMINATION OF MEMBERSHIP

5.1/ Membership in the Association shall terminate:

- a) upon terminating the activity of CKM SYTS
- b) upon written notice by the member of the Association and at the same time upon returning the membership card
- c) upon exclusion of a member for violation of the CKM SYTS statutes upon decision of the Board of Directors of CKM SYTS
- d) upon the death of a member

AFFIDAVITS

6.1/ Upon signing this Application for membership – Registration sheet I hereby declare that I have full legal capacity in accordance with the provisions of Section 8 and Section 9 of the Civil Code.

6.2/ Upon signing this Application for membership – Registration sheet I voluntarily, freely and solemnly apply for being a member of the CKM SYTS Association and I fully agree with the current amount of the membership fee with which I was duly acquainted before signing this Application – Registration sheet, as well as with the terms and conditions of membership of the CKM SYTS Association, with which I have become fully acquainted and at the same time I undertake to regularly update all my data listed in this Application for membership – Registration fee. I acknowledge that the membership card is not transferable and that the benefits of the card only apply to the eligible member of the Association. I agree with the sending of information related to membership and about the scope and possibilities of using the benefits resulting from association membership and use of the membership card to the e-mail address, postal address, mobile phone number (SMS, phone call) which I have specified for such purpose, and at the same time I hereby grant my consent to take and use the photos of myself for the purpose of identifying my person on a membership card. Sending under the previous sentence may also be performed by automatic electronic mail and may be of advertising or marketing nature, with which I, as a member of the Association, agree by signing this Application.

6.3/ I also declare that all the personal data I have provided in this Application – Registration sheet are true and have been provided voluntarily and freely.

CONSENT TO THE PROCESSING OF PERSONAL DATA UNDER ACT NO. 18/2018 ON PROTECTION OF PERSONAL DATA AND AMENDMENTS TO CERTAIN ACTS (hereinafter referred to as the "Personal Data Protection Act")

1. A member of the Association as the data subject pursuant to the Personal Data Protection Act (i.e. any natural person whose personal data is processed by the information system operator under the Personal Data Protection Act) is informed that s/he shall have the right, not obligation to provide his/her personal data to CKM SYTS association as the operator of his/her personal data,
- the identification data and contact details of the operator are listed in the heading of present consent,
- the purpose of the processing of personal data is the fulfillment of the obligation of the CKM SYTS civic association specified in the Statutes and this Application to its members,
- the legal basis for the processing of personal data is the written consent of the data subject and the fulfillment of the obligations of CKM SYTS that are imposed on the data subject as a member of CKM SYTS (performance of the contract),
- the operator intends to transfer the personal data of the data subject to the Netherlands, namely to the organization **ISIC Global Office with its registered office at Keizergracht 174, 1016 DW Amsterdam, the Netherlands,**
- the retention period of personal data is limited by the membership of data subject in CKM SYTS,
- s/he shall have the right to request from the operator the access to personal data relating to him/her, i. e. whether CKM SYTS processes personal data relating to him/her, the purpose, category and time period of processing of personal data, and others.
- s/he shall have the right to withdraw this consent at any time,

- s/he shall have the right for correction of incorrect personal data relating to him/her by CKM SYTS without undue delay. With regard to the purpose of the processing of personal data, the data subject shall be entitled to supplement incomplete personal data,
- s/he shall have the right for erasure of personal data relating to him/her by CKM SYTS without undue delay, in particular, but not exclusively, if personal data are no longer necessary for the purpose for which they were acquired or otherwise processed, or if s/he withdraws present consent,
- s/he shall have the right for restriction of processing of personal data by CKM SYTS, in particular, but not exclusively, if a member of the Association has objected to the accuracy of personal data during a period allowing CKM SYTS to verify the accuracy of personal data,
- s/he shall have the right to be informed by CKM SYTS of the correction of personal data, the erasure of personal data or the restriction of processing of personal data, unless this is shown to be impossible or it requires the undue efforts,
- s/he shall have the right to receive personal data relating to him/her which s/he has provided to CKM SYTS in a structured, commonly used and machine readable format and the right to transfer such personal data to another operator if technically possible,
- s/he shall have the right to object to the processing of his/her personal data by the CKM SYTS, due to CKM SYTS's lack of legitimate interest in the processing of personal data or the lack of a legal claim. Until such time as the aforementioned have been proved, CKM SYTS may not process personal data,
- s/he shall have the right to object to the processing of personal data relating to him/her for the purposes of direct marketing, including profiling, to the extent to which it relates to direct marketing. If data subject objects to the processing of personal data for the purposes of direct marketing, CKM SYTS may not furthermore process personal data for the purposes of direct marketing,
- s/he shall have the right not to be affected by a decision which is based solely on the automated processing of personal data, including profiling, and which has legal effects eligible to have an impact on him/her or to have a similar significant effect on him/her,
- as to all requests made by the data subject and filed electronically, CKM SYTS shall provide information electronically unless the data subject requested information to be provided otherwise. In the case of a different form of the request by the data subject, the form of the CKM SYTS' response is subject to the own discretion of the data subject, however at all times in a manner enabling the delivery of the response,
- all requests made by the data subject shall be responded free of charge, unless otherwise stated herein, and the applicant is required to pay CKM SYTS the delivery cost (postage expenses) if the applicant requests delivery otherwise than electronically. If the request of the data subject is obviously unjustified or unreasonable, in particular due to its recurring nature, CKM SYTS may request a reasonable fee taking into account the administrative costs or refuse to act upon the application,
- s/he shall have the right to file a motion for action so that the Office for Personal Data Protection may establish whether the rights of natural persons have been violated in the processing of their personal data or whether this act related to personal data protection has been infringed. The template of the proposal is published on the website of the Office for Personal Data Protection,
- if s/he does not have full legal capacity, his/her rights may be exercised by a statutory representative,
- if the data subject is deceased, his/her rights under the Personal Data Protection Act may be invoked by a close person,
- CKM SYTS may not enforce the consent of the data subject and condition it by the threat of denial of the contractual relationship, service, goods or obligations imposed on it by the law.

2. A member of the Association as the data subject shall have the right, upon written request, to require from CKM SYTS:

- a) in a generally understandable form, information on the processing of personal data in the information system in the following scope: the processor's identification data; an advice of voluntariness or obligation to provide the required personal data; third parties, if foreseen or obvious that personal data will be made available to them; the form of disclosure if personal data are to be disclosed; the range of recipients, if foreseen or obvious that personal data will be made available to them; third countries, if foreseen or obvious that the transfer of personal data to such countries will be performed.
 - b) in a generally understandable form, accurate information on the source from which it obtained his/her personal data for processing.
3. As a member of the Association – the data subject exercises his/her right:
- a) in writing, if it appears from the content of his/her application that s/he exercises his/her right,
 - b) personally in oral way, to the record, from which it must be clear who has exercised the right to claim, what is claimed and when and who has drawn up the record, the signature of such person and the signature of the data subject; CKM SYTS is obliged to hand over a copy of the record to the data subject,
 - c) electronically to the e-mail address recepcia@ckmsyts.sk,
 - d) against the processor, who shall be obliged to hand over such request or record to the operator without undue delay.

4. Consent to the provision of personal data

- a) By signing this Consent to provision of personal data, I solemnly declare that I have been acquainted that personal data on behalf of CKM SYTS as the operator shall also be processed for the purposes specified herein by the processors, namely: the college identified in the heading of this Consent as the processor under Section 5 point p) of the Personal Data Protection Act and other processors, whose identification data are published on http://ckmsyts.sk/dokumenty/republika_zruzenia_CKM_SYTS.pdf.
- b) By signing this Consent, I further solemnly declare that, pursuant to Section 13 (1) point a) of the Personal Data Protection Act I voluntarily and freely grant as the data subject to the CKM SYTS association as an operator of information system, in which data of natural persons is processed using the automated and non-automated means of processing, consent to the processing and use of my personal data in the scope of: name, surname, academic degree, date of birth, residence (permanent residence, temporary residence), e-mail address, telephone number, school, faculty, year and level of study, serial production number of the ID card chip, unique identification number of the card and the date of commencement and expiry of validity period of the card, for the duration of my membership in the CKM SYTS association for the purpose of: fulfilling the duties and accepting rights arising from membership of the Association by CKM SYTS, for the purposes of my identification as a member of CKM SYTS and the user of the benefits associated with membership of CKM SYTS, for the purpose of sending information related to the membership and the possibilities and extent of using the membership card which may also be of marketing nature and, where appropriate, advertising by contractual partners relating to the granting of benefits resulting from membership of CKM SYTS, for purposes related to CKM SYTS's activities under its statutes and for statistics, documenting and records keeping. For the purposes of the consent expressed in this Application, a natural person shall also be considered to be a member of the Association at the time after signing the application until payment of the first membership fee.
- c) By signing this consent, I further solemnly declare that I acknowledge and agree that CKM SYTS is authorized, pursuant to Section 47 and subsequent provisions of the Personal Data Protection Act, to transfer my personal data to the extent of: name, surname, date of birth, school, faculty, the unique identification number of the card and the date of commencement and expiry of validity of the card within the Member States of the European Union as well as the Member States of the Agreement on the European Economic Area and to third countries which, according to the European Commission decision, guarantee an adequate level of protection of personal data, in the scope necessary to obtain processing of personal data for the purpose of membership in CKM SYTS.
- d) By signing this consent, I further declare that I acknowledge and agree that CKM SYTS is authorized to disclose and provide my personal data to the extent of: name, surname, school, faculty, client number, serial production number of the card chip, unique identification number of the card and the date of commencement and expiration of validity of the card to another legal entity or natural person (i.e. to a range of all providers of discounts and other benefits that have concluded a special contract with CKM SYTS for that purpose) that will or will not further process them to the extent necessary to obtain processing of personal data for the purpose of membership in CKM SYTS.
- e) By signing this consent, I solemnly declare that I have been duly informed before the signing hereof of the identification data of processors authorized by CKM SYTS as an operator under Section 5 point p) of Personal Data Protection Act to process the personal data, and whose identification data are published on http://ckmsyts.sk/dokumenty/referencie_zruzenia_CKM_SYTS.pdf. At the same time, I acknowledge that the list of processors may change and the updated list of all processors will be published and accessible on the above mentioned page.
- f) At the same time, I declare that all personal data I have provided herein are true and have been provided voluntarily and freely.
