**ADMISSION PROCEDURE**

**General information**

The admission procedure for each level of study **begins with the receipt of an application to the Faculty**. The Faculty **does not confirm receipt of the application**.

In the application, it is necessary to clearly indicate **which form of study the applicant is interested in**, whether in the admission to full-time or part-time study. The application for study is submitted separately for the full-time form of study and separately for the part-time form of study. **In one "Application for higher education studies" form, only one form of study is indicated**. In case of interest in both forms of study, it is necessary to submit two applications, i.e., separately for full-time and separately for part-time form of study and pay twice the admission fee.

**The MBU Faculty of Law prefers submission of electronic applications - in that case it is not necessary to send the application in paper form.**

Only if the applicant does not have the possibility to submit an electronic application, they can send the **application in paper form** to the address: **Právnická fakulta UMB, Komenského 20, 974 01 Banská Bystrica** (MBU Faculty of Law, Komenského 20, 974 01 Banská Bystrica) within the application deadline for the relevant degree –form of study.

If the application is submitted in paper form, the 3rd page of the application form must have the **applicant's handwritten signature**.

**Certified copies of all documents required for the electronic version are attached to the paper application.** If the application is submitted in paper form, it is necessary to **stick a copy of the proof of payment of the admission fee** to the 3rd page of the application (account statement, internet banking statement. The payment order is not a proof of payment, therefore it will not be accepted!).

The MBU Faculty of Law does not require a medical certificate of medical fitness for higher education studies; we accept an application without a medical certificate.

A **structured curriculum vitae** (with the applicant's signature) and an **officially certified copy of the secondary-school graduation certificate** (we do not accept scans) are part of the application for **bachelor's degree studies** (1st level). All **applicants for a full-time bachelor's degree** (whether they submit an electronic application or an application in paper form) submit an officially certified copy of their secondary-school graduation certificate to the Study Office of the MBU Faculty of Law **in person, during the presentation on the day of the admission procedure, or sends it by registered mail to the Study Office of the MBU Faculty of Law no later than 5 days before the admission exam**. Applicants who do not demonstrate fulfilment of the basic conditions for admission to study at the time of verification of fulfilment of the conditions for admission may be admitted to study conditionally, with the obligation to demonstrate fulfilment of the basic conditions for admission to study at the latest on the day designated for enrolment. Otherwise, they will not be enrolled for studies. Applicants for a part-time form of bachelor's degree must submit the documents that form the appendix of the application to the Study Office of the MBU Faculty of Law no later than on the day of enrolment, otherwise they will not be enrolled for studies. **It is not necessary to list the subjects and results of assessments from secondary school, nor the subjects and results of the secondary-school graduation exam in the application** (it applies to both forms of study). Secondary school results and secondary-school graduation exam results will not be included in the result of the admission procedure.

The application for **master's degree studies** (2nd level) also includes a **structured curriculum vitae** (with the applicant's signature), an officially **certified copy of the diploma on the completion of bachelor's degree studies** in the field of *law*, or officially certified copy of the diploma on the completion of second level studies /pursuant to section 56 par. 3 of the Higher Education Act/ in the study field of *law*. **Graduates of 1st level studies** (or 2nd level studies pursuant to section 56 par. 3 of the Higher Education Act) **from another law faculty** are obliged to submit as an attachment to the application a **certified copy of the diploma** of completed previous studies in the field of *law* and a **statement of study results** for this previous study. The above **does not apply to graduates of the 1st level of study** (or even the 2nd level of study pursuant to section 56 par. 3 of the Higher Education Act) in the study field of law from the **Faculty of Law of the MBU in Banská Bystrica**. If applicants submit electronic applications, they must submit the documents that make up the application annex to the Study Office of the MBU Faculty of Law no later than on the day of enrolment, otherwise they will not be enrolled for studies. In the event that applicants have completed the 1st level of studies (or also the 2nd level of studies pursuant to section 56 par. 3 of the Higher Education Act) in the relevant academic year, they shall submit a certified copy of the diploma on completion of this study in the study field of law together with a statement of the results of the relevant study to the Study Office of the MBU Faculty of Law no later than on the day of enrolment, otherwise

they will not be enrolled for the study.

Part of the application **for doctoral studies** (3rd level) is:

- a) structured **curriculum vitae**
- b) officially certified photocopies of **documents on the completion of a master's degree in the law study programme** (university diploma, state examination certificate, supplement to the diploma, or language diplomas);
- c) the **means of study results for the master's study with an indication of the weighted study mean** (a graduate of the master's degree from another law faculty is obliged to submit a statement of the study results for the master's degree with an indication of the weighted study mean as an attachment to the application);
- d) a **list** of published and unpublished **professional and scientific works** (e.g. books, articles, manuals, etc.), possibly expert reviews of these works **and other documents worthy of consideration**, e.g. diplomas from ŠVOČ (students') conferences, documents on professional courses completed, etc.;
- e) **the framework project related to the topic of the dissertation** in the scope of about 5 standard pages, which must contain: **objectives** of the dissertation, **methods** of processing the dissertation, the **state of development of the issue** and the expected **benefit** of the dissertation. The candidate chooses the topic of the dissertation from the topics approved for the relevant academic year, which are published on the Faculty's website in the section "Applicants - Information for PhD candidates";
- f) **the proof of payment of the administrative fee** for the admission procedure.

If applicants submit electronic applications for doctoral studies, they must submit the documents forming part of the application, but above all the **framework project related to the topic of the dissertation and the list of published and unpublished professional and scientific works** (including other documents worthy of consideration) **in paper form** to the Study Office of the MBU Faculty of Law so that these documents are physically present at the Faculty **no later than 6 June 2025**. Graduates of a master's degree from another law faculty are also required to submit a statement of study results for the master's degree with an indication of the weighted academic mean by the specified date.

Applicants for the study at any level who fail to demonstrate the fulfilment of the basic requirements for admission to study at the time of verification of the fulfilment of the requirements for admission may be conditionally accepted to study provided that they must prove the fulfilment of the requirements for admission no later than on the date of study enrolment.

**In all study programmes** of the MBU Faculty of Law, applicants **who have not passed the secondary school graduation exam in the Slovak language** and are applying for a study programme conducted in the Slovak language **must be fluent in the Slovak language at least at the B2 level** according to the Common European Framework of Reference for Languages. The Faculty of Law exclusively accepts a **certificate of command of the Slovak language** as a foreign/second language at the required level (minimum B2), which is **issued by language schools registered by the Ministry of Education and Culture of the Slovak Republic in the Network of Schools and School Facilities of the Slovak Republic** (registered state language

schools and private language schools). Applicants must submit an officially certified copy of a document confirming knowledge of the Slovak language at the required level no later than on the day of enrolment for studies.

**Study applicants who completed the previous level of education abroad** are required to **submit the proof of recognition of formal qualification document obtained outside the territory of the Slovak Republic** under the Act no. 422/2015 Coll. on the Recognition of Documents of Education and on the Recognition of Professional Qualifications, as amended. The accepted applicant must submit the decision on recognition of formal qualification documents not later than on the day of enrolment for studies.

Application deadline and the requirements **for foreign students' admission are identical with the ones applicable to the students from the Slovak Republic**. Tuition fees are regulated by the Regulation on Tuition for the 2025/2026 academic year.

## **Admission requirements for the 1st level of study**

The **basic requirement for admission** to a bachelor's degree is to obtain a complete secondary education or a complete secondary professional education.

**Another requirement** for admission to a **full-time bachelor's degree** is taking the **admission exam and obtaining a sufficient number of points**.

The Faculty will send the registered applicant an invitation and more detailed information no later than one month before the admission exam.

**The admission exam is organized in order to ensure that applicants with the necessary skills and abilities are admitted to the study.** The admission exam for full-time bachelor's study is conducted in the form of a **written test**, which tests secondary school knowledge of the subjects such as **history (Slovak and world history), philosophy, social science, including the basics of law, the basics of sociology, psychology and economics; at the same time, a general socio-political and cultural overview, knowledge of the Constitution of the Slovak Republic, as well as the applicant's logical thinking are tested.** The Faculty will publish the recommended literature for the admission exam for the bachelor's law study programme on its website. The **test consists of a total of 50 questions, the time limit for completing it is 30 minutes.** After completing and submitting the test, the Faculty will allow the applicant, in the presence of a computer operator, to verify the correctness/incorrectness of the answers to the test questions and the amount of points for the test results on the day of the admission exam. The results of the admission exam will be published on the website of the Faculty. According to the points obtained from the written test, the order will be determined from the highest number to the lowest number of points obtained. **The applicant who achieves the number of points required for the expected number of admitted students** in the study programme and form **shall be accepted.** The number of admitted applicants will be in accordance with the approved planned number of admitted applicants for 2025/2026 academic year. **In case of non-participation of the applicant in the admission exam, the fee for the admission procedure shall not be refunded.**

The admission procedure for the **part-time form** of bachelor's degree is **without an admission exam.**

## **Admission requirements for the 2nd level of study**

**Pursuant to section 56 par. 3 of Act No. 131/2002 Coll. on Higher Education, as amended,** the **basic requirement** for admission to a second-level study programme (section 53, paragraph 1 of Act No. 131/2002 Coll. on Higher Education, as amended) is a **completion of the first-level higher education** or a second-level higher education, while the sum of the number of credits obtained for the previous higher education study, which resulted in a higher education degree, and the number of credits required for the proper completion of the second-level study programme for which the applicant is applying, must be at least 300 credits.

For the purposes of the admission procedure for master's degree at the MBU Faculty of Law, a completed higher education degree according to the previous sentence means **successful completion of studies in the law study programme.** Officially certified copy of diploma on completion of bachelor's degree /or second-level studies pursuant to section 56 par. 3 of the Higher Education Act/ in the law study programme must be sent by 30 June 2025, but no later than the date of enrolment for studies.

**Additional admission requirements** for full-time and part-time master's degree:

- according to the order of the value of the **weighted study mean** from the bachelor's degree /or of previous studies of the second level pursuant to section 56 par. 3 of Act No. 131/2002 Coll. on Higher Education as amended/,

- bachelor's degree graduate /or graduate from previous studies of the second level pursuant to section 56 par. 3 of Act No. 131/2002 Coll. on Higher Education as amended/ **from another law faculty** is required to submit a **statement of study results** as an attachment to the application.

The number of admitted applicants will be in accordance with the approved planned number of admitted applicants for 2025/2026 academic year.

### **Admission requirements for the 3rd level of study**

The **basic requirement** for admission to full-time and part-time doctoral studies is the **successful completion of a master's degree in law study programme.**

**Another admission requirement** is the successful completion of the **admission exam**, in which the examination committee appointed by the Dean determines the applicant's readiness for the given doctoral study programme in the following categories (ranked by importance from the most important one):

- **project related to the topic of the dissertation** - applicants submit and present their own (author's) project on the topic of the dissertation (within the scope of 5 standard pages of the text) - the originality and content of the project, the presentation of the project and the applicant's answers and reactions to the committee's questions in relation to the project are assessed - in this category; applicants can receive a maximum of 50 points (of which a maximum of 20 points for the elaboration of the project – the originality and content of the project; a maximum of 20 points for the presentation of the project and a maximum of 10 points for the applicant's answers and reactions to the committee's questions in relation to the project);
- **knowledge in the scope of a second-level higher education in a given field and the professional and scientific overview of the applicant in the chosen field** - are assessed by an oral interview (especially answers to the committee's questions) - in this category, the applicant can get a maximum of 20 points;
- **prerequisites for scientific activity** - are assessed by the applicant's own publication and other scientific activity - in this category, the applicant can receive a maximum of 20 points;
- **command of one of the languages: English, German, Russian, French or Spanish at least at level B1** according to the Common European Framework of Reference for Languages - the applicant will submit a certificate of command of a foreign language at the required level or the examination committee will check the language knowledge through an oral interview - in this category the applicant can get a maximum of 10 points.

The admission exam will take place **orally**. Applicants for doctoral studies must demonstrate knowledge, skills and abilities from the field of law, as well as the content, methods and expected results of the dissertation. The examination committee determines the applicant's interest in the study programme, interest in science, and takes into account the study results of the master's degree when making the final decision. The **result of the admission interview in front of the examination committee is taken into account in the admission** to doctoral studies in both full-time and part-time study, **based on the number of points obtained by the candidate**. If **applicants for full-time** doctoral studies do not achieve **at least 75 points** out of 100 in the admission exam, they have not successfully passed the admission exam.



The admissions interview committee evaluates the result of the admission exam in a closed session. Based on the assessment of individual applicants and after taking into account their values of the weighted academic mean from the master's degree, they will determine the order of success. The Dean of the Faculty will decide whether or not to accept applicants, based on the opinion of the admissions interview committee, within 30 days from the date of the admission exam.

The number of admitted applicants is based on the approved planned number of admitted applicants for 2025/2026 academic year. The **Dean of the Faculty of Law of MBU** has the right, based on the current state of the number of admitted applicants, to **decide not to open the study programme in a given academic year**.

## **ORGANIZATION AND COURSE OF STUDIES**

The Faculty of Law of the MBU provides higher education in accredited study programmes, in the Full-Time and the Part-Time form:

- **Bachelor's Degree** - standardly takes three years in the full-time and three years in the part-time study. The study is completed with a state examination, which also includes a defence of the final thesis. Successful graduates are awarded the academic title "**Bachelor**" (abbreviated as "Bc.");
- **Master's Degree** - takes two years in the full-time and two years in the part-time study. The study is completed with a state examination, which also includes a defence of the final thesis. Successful graduates are awarded the academic title "**Master**" (abbreviated as "Mgr.");
- **Doctoral Degree** - takes three years in the full-time and four years in the part-time study. The study is completed with a defence of the dissertation, which is, after completion of appropriate requirements, preceded by the dissertation examination. Successful graduates are awarded the academic title "**Philosophiae Doctor**" (abbreviated as "PhD").

Tuition fees for 2025/2026 academic year will be paid according to the Regulation, which will be approved for that academic year.

## **ACCOMMODATION AND BOARD OPTIONS FOR STUDENTS**

Students of the UMB Faculty of Law have the option of accommodation in student hostels. Student canteens provide the possibility of meals.

## **RIGOROUS EXAMINATION**

Graduates of the study programme Law, who earned the title "Master" or of similar study programmes abroad can take **rigorous exam**, which includes a defence of thesis in the field of study in which they graduated. After successful completion of rigorous examination the applicant is awarded the academic degree "**Doctor of Laws**" (abbreviated as "JUDr.").

## **GRADUATES PROFILE AND EMPLOYMENT OPTIONS**

### **Graduates of Bachelor's Degree (Bc.)**

Graduates of the **study programme in law at the bachelor's level of study** have adequate knowledge of individual legal branches, within which primary individual profile subjects are taught (Roman law, history of law, theory of the state and law, constitutional law, administrative law, substantive and procedural civil law, labour law, public international law) and identify mutual connections between them. They understand the interdisciplinary nature of law, its close connection with application practice, the importance of court decisions and doctrinal opinions. Graduates of the bachelor's study programme in the field of law have all the necessary knowledge and understanding of the theory of the state and law, the separation of powers, the principles of the functioning of the rule of law, and know the historical determinants of the development of law and its key institutions. They have the necessary knowledge of substantive and procedural law and administrative justice. They control the material of civil substantive and procedural law, as well as the basics of labour law. Graduates of the law study programme at the bachelor's level of study master the methodology of interpretation and application of legal norms and ascertainment of the facts within individual legal branches. They orient themselves in the systems and methods of obtaining legally relevant information (mainly legal regulations and related documents, decisions of courts and administrative bodies, professional and scientific legal literature) and are able to search for case law and the current state of legal opinions (doctrine) in relation to specific issues. The graduates are characterized by independent abstract, analytical and critical thinking. They know how to communicate at the necessary level in the Slovak language in written and oral form, to convey information in the work team and in the external environment, to defend their positions and proposals. They can argue and justify their opinions, positions and proposals to the necessary extent. The graduates are qualified to carry out preparatory work within the judiciary, to work as specialists in state administration and self-government, in the field of legal management or in the non-governmental sector.

### **Graduates of Master's Degree (Mgr.)**

The **master's study programme in law** is identical in content to the areas and scope of knowledge, skills and competences required for a graduate of the study programme according to the National Qualification Framework SKK-7. The requirement for completing this study programme is the previous successful completion of a bachelor's degree in the law study programme, which in combination is an elementary prerequisite for the future performance of the indicated professions in the judicial sphere, as well as practically all so-called independent legal professions (lawyer, notary, bailiff, etc.), but also professions in other fields (e.g. corporate lawyer). Graduates have extensive theoretical-legal, legal-philosophical and historical-legal knowledge, acquired in the first level of studies in the law study programme, fundamentally expanded by knowledge of positive legal subjects (civil law, criminal law, commercial law, labour law) and the ability to apply the law in practice, also through clinically conceived subjects, such as clinic of civil law i and ii, clinic of commercial law, tax law in theory and practice, clinic of media law, clinic of personal data protection, legal clinic for communities, law of commercial companies, bankruptcy law, etc. They can connect interdisciplinary contexts and take an active role in the creation of legal regulations. The graduates are able to perceive and use interdisciplinary contexts and overlaps of legal institutes and can use them in applied legal practice. The graduates have developed orientation skills in the national legal order, in the legal system of the European Union and in international law. They are therefore capable of

comprehensively solving legal problems in both their national and transnational contexts with the necessary consideration of European Union law and international law. In individual legal areas, they solve problems of a substantive and procedural nature and propose their effective solution, including using the ability to work with the results of the decision-making activities of national, community and foreign courts. The graduates independently solve the ethical dilemmas that they will encounter in the performance of their profession. They can independently expand and deepen the acquired knowledge, methodically analyse programme and procedural problems of legal practice and master procedures and skills in providing legal advice. When performing their profession, they are able to reflect the position and roles of a lawyer in society. The graduates are able to think abstractly, think analytically, synthetically and contextually, formulate, propose and apply legal opinions and considerations in solving complex legal problems. The graduates are competent to independently carry out more demanding work in the field of public administration and in the private, primarily commercial sphere (such as a corporate lawyer) or work as candidates for legal professions (judiciary, prosecutor's office, advocacy, notary, enforcement of decisions, bankruptcy administration, etc.), employees in the judicial sphere (senior court official, bailiff, judge and others).

### **Graduates of Doctoral Degree (PhD.)**

The **doctoral study programme in *commercial and financial law*** is identical in content to the areas and scope of knowledge, skills and competences required for graduates of the study programme according to the National Qualification Framework SKK-8. The requirement for completing this study programme is the previous successful completion of a master's degree in the law study programme. The graduates master the scientific methods of basic and applied research in legal sciences, which serve as a basis for carrying out research and development and creating new scientific knowledge in the field of law. The graduates are focused on commercial and financial law. The graduates have a systematic, comprehensive and overall set of knowledge in the field of commercial and financial law in the following subfields - the status of commercial companies, commercial obligations, securities, public law regulation of business, bankruptcy law, financial law, tax law, economic law and related disciplines, including knowledge and understanding of the relationships between them, as well as to other parts of the field, primarily civil law. The graduates also have a deep knowledge of theories, sophisticated methods and procedures of science and research at a level corresponding to international criteria. ### **INFORMATION FOR APPLICANTS WITH SPECIAL NEEDS**

The Faculty of Law of the Matej Bel University in Banská Bystrica in accordance with section 100 of Act no. 131/2002 Coll. on Higher Education Institutions and on Amendments to Certain Laws as amended and Decree No. 458/2012 on the Minimum Requirements of a Student with Specific Needs creates the appropriate study conditions for full-time and part-time students with specific needs, due to their special study needs, **without reducing the study requirements**. Persons with special needs are people whose physical or mental abilities limit their functioning in the normal environment and in common situations.

#### **The status of a student with specific needs is given to the student:**

- a) with sensory, physical and multiple disabilities (visual disability, hearing disability, limb sufferers, dysfunction of fine motor skills);
- b) with chronic diseases (cystic fibrosis, epilepsy, asthma, multiple sclerosis, diabetes mellitus, organ or tissue transplantation, cardiovascular disease, neurological disease);
- c) with health weakening (after long-term illness, convalescence, reduction in disease resistance or tendency to recurrence);
- d) having a mental illness;
- e) with autism or other pervasive developmental disorders (e.g., Asperger syndrome);
- f) with learning disorders (dyslexia, dysorthography, dysgraphia, dyscalculia, etc.).

#### **Before applying for higher-education studies it is necessary to:**

1. consider own abilities to study at a higher-education institution in terms of:
  - a) knowledge level;
  - b) level of knowledge of the Slovak language;
  - c) technical and personal readiness and motivation;
  - d) claims on content, scope and form of study;
  - e) conditions of the Faculty;
  - f) disability limits.
2. Contact a Faculty coordinator for students with specific needs.
3. Submit a report from a specialist, a psychologist, a speech therapist, a school psychologist, a school therapist, or a special pedagogue (for more information see the Study Guide for Students with Specific Needs at Matej Bel University in Banská Bystrica).
4. Submit a request from an applicant with specific needs to modify the form and method of conducting the admission exam, with relevant professional documentation documenting the specific needs of the applicant (if the admission exam is part of the verification of the ability to study).


The final decision to study the selected study programme is made by the applicant. By making the decision they take responsibility for any risks that they will not be able to continue with the studies.
