The Joint study programme is a result of long term cooperation between the Faculty of Economics of Matej Bel University (MBU) in Banská Bystrica and the European University Center at the University of Lorraine in Nancy within francophone studies. Under the cooperation agreement and the addendum to this agreement signed in 2012, the joint study programme is based on the Finance, Banking and Investment Master's degree programme at the Faculty of Economics of MBU and Gestion financière et espace européen Master's degree at University of Lorraine.

Requirements for graduation from the joint study programmes and obtaining double degree are: completion of selected courses from partnering institution's curriculum amounting to 30 ECTS credits during at least one term.

Students studying the *Gestion financière et espace européen* study programme will attend courses highlighted in bold during their mobility at the Faculty of Economics of MBU in the winter term. Students studying the **Finance, Banking and Investment** study programme will attend said courses during their mobility in the summer term at the University of Lorraine in the French language.

Mandatory courses *Macroeconomics 2, Financial Management 1, International Finance, Banking and Insurance Business, Risk and Uncertainty in Finance* will be recognized as completed after completing *Ouverture des marchés, politique de régulation* and *Economie, gestion financière en environnement international* courses.

The Diploma thesis course involves a Diploma seminar, Diploma practice and the Diploma thesis itself. Students will write their thesis either in the French or Slovak language. If the thesis is in the Slovak language, a résumé in the French language has to be included.

Faculty of Economics students enrolled in the joint study programme are studying under the individual curriculum. Students will complete courses highlighted in bold during the mobility at the partnering University, Chorzow School of Banking, in the English language. The rest of the courses are completed at the Faculty of Economics of MBU in Banská Bystrica. Students of the Faculty of Chorzow of Poznan School of Banking will enrol in courses for the Marketing Management of Business curriculum amounting to 30 ECTS credits on the basis of the joint study programme agreement. Courses are available in the English language as well.

The joint study programme **Finance, Banking and Investment** is provided by the Faculty of Economics of MBU in Banská Bystrica and the Faculty of Chorzow of Poznan Banking School (Poland). Faculty of Economics students will spend the summer term at a partnering university in Poland and Polish students will attend selected courses in the Faculty of Economics of MBU during the winter term. The joint study programme is structured to ensure courses completed at partnering institutions fully correspond with the scope of study at each home faculty and aptly shape future graduates in this programme.

Students studying in the Master's degree study programme Economics of Tourism Businesses meet the requirements for admission to a double degree study programme for Tourism and Regional Planning – Management and Geography at the Catholic University Eichstaett-Ingolstadt and Economics of Tourism Businesses provided by MBU in Banská Bystrica have their curriculum adjusted accordingly:

- selected courses are taught in the English language by both partnering institutions,
- courses from the curriculum attended on the basis of bilateral agreement are highlighted in bold; every student obtains 60 ECTS credits from the partnering institutions, 120 ECTS credits together from both the Faculty of Economics of MBU and the Catholic University at Eichstaett-Ingolstadt,
- Catholic University Eichstaett-Ingolstadt students enrolled in a double degree Master's degree study programme must complete courses amounting to 60 ECTS credits in the English language (highlighted in the curriculum in bold) with at least one term at the Faculty of Economics of MBU,
- Diploma thesis is written in the English language and amounts to 30 ECTS credits.
- graduation, including a diploma thesis defense, is conducted in front of a joint committee with the possibility to use ICT (Information and Communication Technologies)

5. The Joint Study Programme Droit des Collectivités Territoriales de l'UFR de Droit et de Science Politique de l'Université de Reims Champagne-Ardenne and Regional Economics and Administration by Faculty of Economics Matej Bel University, Banská Bystrica

As a result of long term cooperation between the Faculty of Economics of MBU and the University of Reims Champagne-Ardenne (URCA) and on the basis of a bilateral agreement of cooperation signed in 2012, creation of a joint study programme provided by both partnering institutions was made possible. The joint study programme is based on the Master's degree study programme Regional Economics and Administration at the Faculty of Economics of MBU and the Master's degree study programme for Regional Administration and Local Development at the Faculty of Law and Politics URCA. The Basic requirements for obtaining a double degree are completion of one term at the partnering university and obtaining 30 ECTS credits under the recommended curriculum.
